JOB DESCRIPTION

Job Title and Grade	Senior Speech and Language Therapist CDNT
Location of Post	Based in CRC Lead Agency Children's Disability Network Teams. The CRC Children's Disability Network Teams (CDNT) will be providing intervention to children from the age of 0-18 years, presenting with complex developmental needs requiring inter-disciplinary intervention. Our services are based upon a Family Centered Practice Model in line with the Progressing Disability Services. CRC CDNTs are based in Clontarf, Swords Balbriggan, Clondalkin and Waterford.
Details of Service	The post holder will have responsibility for provision of a high quality speech and language therapy service within an interdisciplinary children's disability network team.
Reporting Relationship:	The post holder will have a reporting relationship to the Children's Disability Network Manager. The CDN M will provide clinical assurance regarding professional supervision in collaboration with the Speech and Language Therapy Manager.
Key Working Relationships:	The post holder will: • Work with and report to the CDN M • Liaise with the Speech and Language Therapy Manager as agreed • Work as part of the inter-disciplinary children's network disability team • Work within the clinical supervision framework as agreed • Engage in the process of reconfiguration under Progressing Children's Disability Services national policy.
Purpose of the Post	The post holder will: • Deliver a range of appropriate Speech and Language Therapy assessments and interventions. • Work with other SLT colleagues and the interdisciplinary team in service delivery. • Have the responsibilities of a Mandated Person as outlined in the Child Care Act 2015.

Principal Duties and Responsibilities	<u>Duties and Responsibilities:</u> <u>Clinical</u> <u>Overall</u> Professional Knowledge and Skill <i>The Senior Speech & Language Therapist will:</i> • Demonstrate knowledge of typical and atypical development, and specifically the impact of a disability on a child's functional development with implications for participation. • Be responsible for assessment, diagnosis, planning, implementation and evaluation of treatment / intervention programmes for service users according to professional standards. • Be up to date and competent in making evidence based clinical decisions following assessment of complex cases. • Demonstrate competency in evaluating referrals and in assessment planning including determining key personnel to attend the appointment. • Demonstrate knowledge of best practice treatment guidelines/pathways for specific conditions. i.e. appropriate interventions along trajectory relevant to specific condition

	• Be competent in reporting and documenting all assessments, diagnoses, treatment / intervention plans, clinical notes, relevant contacts and summaries efficiently, according to specified timelines and in accordance with department and professional standards. • Have experience in conducting and scoring appropriate outcome measures for intervention planning. • Possess advanced skills and knowledge to facilitate collaboration with service user, family, carers and other staff in goal setting and treatment / intervention planning for the service users. • Demonstrate respect for the diversity of service users and their families and contribute to provision of a service sensitive to individual needs as appropriate and based on best practice as per the literature. • Participation within the interdisciplinary team as appropriate, communicating and working in collaboration with the service user and other team members as part of a family centred practice model of service. • Possess a level of clinical knowledge and skill in the area of FEDS • Develop and maintain an up to date knowledge base of evidence-based pathways for assessment and intervention in the area of FEDS • Seek advice and assistance from the CDNM and assigned clinical supervisor with any assigned cases or issues that prove to be beyond the scope of his / her professional competence in line with principles of best practice and clinical governance • Liaise and cooperate with relevant professional bodies as required • Operate within the framework of the organization and comply with the codes of ethical practice. Providing a Quality Service <i>The Senior Speech & Language Therapist will:</i> • Be responsible for the co-ordination, delivery and development of service in designated area(s) in conjunction with the CDNM • To effectively prioritise and manage a clinical caseload in the context of an interdisciplinary team and family centred practice model of service • To work with the CDNM to develop areas of service and to maintain best practice service delivery • Participate in the control and ordering of clinical equipment

	• To participate in the use and development of outcome measures to monitor effectiveness and quality of service provision • To participate in the use and development of performance measures to monitor effectiveness and quality of service provision in accordance with PDS PPPGs, CRC SLT Department and professional standards • Promote quality by reviewing and evaluating the Speech & Language Therapy service, identifying changing needs and opportunities to improve services • Engage in service audit and demonstrate the achievement of the service objectives • Ensure the maintenance of accurate records in line with best clinical governance, the organisation's requirements and the Freedom of Information Act, and provide reports and other information / statistics as required • Ensure good working practice and adherence to standards of best practice • Represent the Speech and Language Therapy perspective within the interdisciplinary team, the department and with external stakeholders and agencies • Represent the CDNT / profession / Department at meetings and conferences as appropriate • Critically engage with and evaluate technological developments as they apply to the service and service delivery • Adhere to and participate in developing CDNT PPPGs, department procedures, standards and quality assurance systems in accordance with CRC, Department of Health and other relevant guidelines such as Health and Safety at Work Act • Maintain professional standards in relation to confidentiality, ethics and legislation • Operate within the scope of Speech & Language Therapy practice as set out by the Irish Association of Speech & Language Therapists and in line with CORU regulations • Participate in and develop activities which support health promotion • Carry out other duties as assigned by the CDNM • Keep up to date with change and developments within the Irish Health Service.
